

# Wardway Pool Service

## Information for 2009 Pool Openings

### FULL SERVICE POOL OPENING

\$190 + chemicals & materials (up to 1¼ hours. Additional labor time is billed @ \$79 per hour)

Includes:

- Cover removal, cleaning of winter cover & treating with Stow Away (cover preservative, customer responsible for storage)
- Reassemble pump, filter, and heater (if applicable)
- Removal of winterization fittings and installation of in-season fittings
- Testing pool water chemistry and adding Start-up chemicals (chemicals extra cost)
- Cleaning of the top seats (if applicable) and debris around immediate pool coping
- Reinstalling railings, ladders, and any necessary fittings
- We do not install diving boards.

### POOL OPENING W/O COVER SERVICE

\$125 + chemicals & materials (up to 45 minutes-additional labor time is billed @ \$79/hour)

#### Customer Requirements:

- Remove as much water from the top of winter cover as possible
- Have all equipment out and by the pool
- Have water and electric available for our use
- Storing the winter cover and all other winter accessories
- **Raise water level in pool to normal operating level prior to our arrival. There will be a charge for return visits if pool water is not at proper operating level.**

#### Extra Charges:

Pump water off cover \$55 (up to 30 min.)

\$70 (over 30 min.)

Full Deck around pool (aboveground) \$35.00

Repair pump or filter \$55.00/hr. (plus parts)

Any materials additional materials needed (chemicals, sand, DE, filter hoses, etc.....)

Remove Leaf Net \$20.00

Vacuuming \$79/hr if time allows

1. Wardway Grill & Pool will not be expected to do any work other than that which is listed above unless pre-arranged.
2. Due to the possibility of pre-existing conditions, Wardway Grill & Pool does not take responsibility for leaks in filter pipe connections or any other leaks.
3. Wardway Grill & Pool will not assume responsibility and/or liability for damages caused by the removal and reinstallation of equipment that is corroded, rusted, stripped or other such conditions, including decks. These items will be replaced at the owner's expense.
4. Wardway Grill & Pool is not responsible for verbal agreements. All services must be in writing and agreed upon before the time of service.
5. Payment is expected upon time of service. If a check is not given to us at the time of service, all services will be charged to your credit card account which was provided by you at the time of scheduling.
